Location: Historic Blanco Town Square, Blanco, Texas 78606
Days & Times: Saturday, April 13th, 2019, 9:00 am – 5:00 pm
Move-In: 7 – 9 am
Move-Out: 5:00 pm – Dark
Grounds: Downtown Blanco on the Old Blanco County Courthouse square

Eligibility: Open to individual artists and craftspeople presenting original works. A select group of manufactured, imported or resale items will be allowed in the arts and crafts area; however, only those of the highest quality and in keeping with our festival's standards will be considered. Demonstrating your art or craft, while not required, is considered a bonus. To maintain the quality and balance of the arts and crafts shown, this is a juried show. The Wild Woman Weekend Market Committee ("Committee") reserves the right to reject any display that is not in keeping with the examples submitted to the jury.

About the Jury: A jury, including artists and craftspeople will judge the photographs you present for consideration. Please be sure to submit clear pictures that accurately portray your work.

Registration: The registration fee will be \$55 per 10' x 12' space for the one-day show. There will be no price limit on your items sold, and no commission will be taken. All registration forms must be completed and accompanied by a minimum of 4 photographs and a check, payable to the OBCCPS-Wild Woman Market. Money orders and cash are also accepted. Your photographs will be kept on file and will not be returned. Your payment will not be processed until you have been accepted into the show, and will be returned if you are not accepted. There are a limited number of spaces. Please apply early!

Booth Spaces: 10' x 12' open spaces are provided. You provide your own canopy. Canopy corners must be secured by weights, as tent stakes are not permitted on the courthouse grounds. Electricity will be available on a strictly limited basis, at an additional charge of \$15.00 per space. Please note: electricity may be used for fans, basic lighting, cash registers, and credit card machines ONLY. No generators are allowed. Booth spaces cannot be transferred to another vendor without written approval from the Committee.

Notification of Acceptance: You will be notified of your acceptance no later than ***February 15, 2019.*** Please note: there will be no refunds after acceptance and no refunds should bad weather or illness occur.

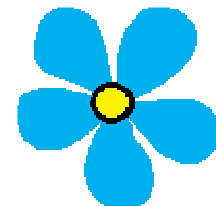

GENERAL RELEASE AND HOLD HARMLESS AGREEMENT**

For and in consideration of OBCCPS (established as a separate 501(c)(3) Texas non-profit corporation permitting me, my company, my employees, my family members and/or our guests, to participate as a Vendor in the Wild Woman Weekend Market, I hereby release, OBCCPS, their agents and employees from all claims, demands, suits, causes of action, or judgments which I ever had, now have, or may have in the future or which my heirs, executors, administrators, or assigns may have, or claim to have against OBCCPS, their agents and employees, arising out of or in any way connected with Wild Woman Weekend, for all personal injuries, known or unknown, property damages, or claims for wrongful death, caused by the acts, omissions, or negligence of OBCCPS, their agents and employees.

I FURTHER AGREE TO INDEMNIFY AND HOLD HARMLESS OBCCPS, ITS AGENTS AND EMPLOYEES, FROM ALL LIABILITY, LOSS, DAMAGES, DEBTS, LIENS, CHARGES, JUDGMENTS, EXECUTIONS, COSTS, PENALTIES AND EXPENSES OF ANY NATURE (INCLUDING BUT NOT LIMITED TO ATTORNEY'S FEES AND COURT COSTS), INCURRED BY OR ON BEHALF OF OBCCPS, ITS AGENTS AND EMPLOYEES, ARISING OUT OF OR IN CONNECTION WITH ANY CLAIM THAT I, ANY FAMILY MEMBER, AND/OR ANY OF OUR GUESTS AND/OR CUSTOMERS EVER HAD, NOW HAVE, OR MAY HAVE IN THE FUTURE OR WHICH MY OR MY GUEST'S OR CUSTOMER'S HEIRS, EXECUTORS, ADMINISTRATORS, OR ASSIGNS MAY HAVE, OR CLAIM TO HAVE AGAINST OBCCPS, ITS AGENTS AND EMPLOYEES, ARISING OUT OF OR IN ANY WAY CONNECTED WITH THE WILD WOMAN WEEKEND EVENT IN BLANCO COUNTY, TEXAS, FOR ALL PERSONAL INJURIES AND/OR WRONGFUL DEATH, ALL PROPERTY DAMAGES, AND ALL OTHER DAMAGES OF EVERY TYPE, KNOWN OR UNKNOWN, ARISING IN WHOLE OR IN PART OUT OF THE ACTS, OMISSIONS, OR NEGLIGENCE OF OBCCPS, ITS AGENTS AND/OR EMPLOYEES, INCLUDING SPECIFICALLY ALL SUCH CLAIMS AND/OR DAMAGES ARISING OUT OF THE SOLE NEGLIGENCE OF OBCCPS, ITS AGENTS AND/OR EMPLOYEES. I FURTHER AGREE THAT THIS INDEMNITY PROVISION IS CONSPICUOUS AND ENFORCEABLE AND MEETS THE PROVISIONS OF THE EXPRESS NEGLIGENCE TEST.

I also hereby release the Blanco Non-Profit Coalition and any and all of its members, directors, officers and employees from any responsibility for any injuries to me or my employees and for any loss or damage to personal property while participating in the 2019 Wild Woman Weekend Market.

I further understand and agree that there will be no refunds after acceptance or should bad weather or illness occur and that I have no claim or demand to a refund.
